

JANUARY 1970 BOARD MEETING

A regular meeting of the Board of Directors was held on Sunday, January 18, 1970.

New officers elected by the Board for 1970 are Russell Koehring, President; Glenn Brown, Vice-President (Finance); Jerry Johnson, Vice-President (Operations); and Calvin Warren, Secretary-Treasurer.

After discussing the objectives to be accomplished during the year, it was agreed that two committees would be required - Association Property and Lake & Dam. Several persons were suggested for heading these committees but no agreement was reached. All Board members agreed to present names and make selections at the February meeting.

The remodeling of the North Side Beach and docks was discussed. It was agreed that the lake wall to be constructed would be the most critical and expensive part of the construction and, as such, must be designed by a competent engineer. Several Board Members having acquaintances among engineers will solicit their assistance.

Since John Repass has been a member of Natural Resources, Inc., and attended many of their meetings during the past year, he agreed to serve as the Board's representative with NRI.

RESERVOIR REPORT

As reported recently in local newspapers, the Army Corps of Engineers is considering two possible locations for a flood control dam and reservoir in northeast Marion County. The preferred location for the dam is in the vicinity of Boy Scout Road and Fall Creek with a secondary choice of a dam between 71st Street and 79th Street on Fall Creek. A public hearing will be held in the next 60 to 90 days on these proposals. You will be notified of the exact date when it is announced and advised of any assistance you can give in opposing the Boy Scout Dam which would inundate Indian Lake and much of the surrounding
